Introduction from the Chair

- Request for AOB no requests
- Previous minutes ratified and added to the OpenSAFELY Governance page prior to the meeting
- Review of actions ToR have been revised to reflect recent funding award

Review <u>Terms of Reference (ToR)</u>

- ToR revised to reflect:
 - Evolving governance for OpenSAFELY (OS)
 - o Advisory Board/ Oversight Group's contribution to decisions on tech and software
 - o Oversight group view of the wider strategic picture
 - Potential new members
- Decision that the Oversight Group will meet for at least seven years (Wellcome Trust funding term) but effectiveness will be reviewed periodically
- Membership of this Oversight Group and the NHS Steering Group and the separate function of each group

Bennett Team Update

- Funding
 - Two new grants awarded:
 - OpenSAFELY Talking Therapies from the Wellcome Trust
 - Baily Thomas Foundation to investigate mortality risk in patients with Intellectual Disability and Epilepsy
 - Two applications in progress:
 - MRC Enhancing Platforms grant first of its kind open call, which will allow accelerated work on data ingestion service for OS
 - NIHR Programme Grant to develop methods for evaluating effectiveness of respiratory vaccines using OpenSAFELY led by Jonathan Sterne
- Staffing
 - Bl currently at 60 staff, due to increase to ~80 by end of 2025
 - Improved team diversity, particularly in Engineering (from 14% to close to 50% of women on the team)
- Outputs
 - No new preprint papers at this time, due to COVID applications reducing, but some interest remains in conducting research into long COVID and vaccines in pregnancy
 - Three papers have recently been published:
 - <u>Ursodeoxycholic acid and severe COVID-19 outcomes in a cohort study using the OpenSAFELY platform</u>
 - The use of Online Consultation Systems or Remote Consulting in England
 Characterized Through the Primary Care Health Records of 53 Million People
 in the OpenSAFELY Platform: Retrospective Cohort Study
 - Impacts of the COVID-19 Pandemic on Deprivation-Level Differences in Cardiovascular Hospitalisations: A Comparison of England and Denmark Using the OpenSAFELY Platform and National Registry Data
- Tech
 - o Improvements on management of permissions for researchers and OS staff
 - Enhanced OS query language (ehrQL) capability to make it easier for researchers to learn

NHSE Update

- Budget for next year: spending review in progress
- Legal basis and timeline for non-COVID research

- o 26th Feb: JGPITC meeting
- Next step: NHSE to inform GP practices and share formal Data Provisioning Notice
- 'Go live' hopefully April/May, for TPP initially with EMIS to follow
- Commercial Arrangements with GPSS (EMIS & TPP)
 - o Regular discussions with EMIS that are positive
 - Discussions with TPP ongoing

OpenSAFELY Schools

- Funding from XTX Markets and Nuffield Foundation
- Plans to explore stakeholder communications and engagement with the National Institute of Teaching (NIoT)
- Ambitions beyond initial research; to unlock national scale data and help make it interpretable and actionable
- Timeline: two year timeline, to prove OS works in this area and generate future funding to move beyond proof of concept

National Data Library

- BG introduced the Bennett Institute Submission to the recent ESRC/Wellcome Trust call for proposals on how a National Data Library (NDL) should work. The paper proposed that:
 - Work should be spread across a network of services/standalone components which combine to form a 'platform' and creates a more resilient model
 - This should reuse existing components but change/tailor some elements (e.g. the data prep services) to suit each organisation
- Next steps:
 - o Conversations with NDL team
 - Seek co-funding for a pilot project with continued team focus on working pilot and delivery

PPIE Update

- Conclusion of six online public participation events, co-designed piece with Digital Critical Friends (DCFs) discussing the expansion of OpenSAFELY to include non-COVID-19 research
- The feedback of these findings will be detailed in a report, and shared with NHSE to support wider development of the service
- High level of engagement from those that attended and workshops well-received 4.5/5 rating
- Wide variety of people attended and level of technical knowledge varied within the groups
- Recruitment to the DCFs ongoing and there is a mailing list of members of the public expressing interest in participating
- Meeting with National Institute of Teaching to ensure appropriate public engagement for OS-Schools

Conference and OpenSAFELY Book

- First conference was a great success and gathered major stakeholders, with over 200 attendees.
- A booklet on the past, present and future of OS was distributed and well received
- High Impact work conducted using OS highlighted and technical workshops showed strong support for growth of the service
- All talks were filmed and are available on the Bennett Institute website here
